COUNCIL MEETING MINUTES
MAY 11, 2016

The regular meeting of the Goodhue City Council was held on May 11, 2016. Members present were the Honorable Kerry D. Bien, John Adams, Leia Ryan and Wayne Hahn. Absent was Tia Schimek. Also present were Richard Gorman, Jennifer Marquardt, Brent Nelson, Corey Roper, Matt Cordes, Justin Roper, and Roz, Kris and Linda Allers.

Motion was made by Leia Ryan, seconded by John Adams to approve the agenda. Motion passed unanimously.

Motion was made by Wayne Hahn, seconded by John Adams, to approve the minutes of the April 27, 2016, meeting. Motion passed unanimously.

Jennifer Marquardt requested a fence permit on her yard. A motion by Leia Ryan, seconded by John Adams, to approve the fence permit as long as it meets all applicable City ordinances. Motion passed unanimously.

Motion by Leia Ryan, seconded by Wayne Hahn, to approve the deck permit for Corey Ryan, as long as it meets all applicable standards as required by the County Inspector. Motion passed unanimously.

Motion by Leia Ryan, seconded by Wayne Hahn, to grant the building permit to Brent Nelson for his new home. Motion passed unanimously.

The Council then discussed various annexation issues with affected property owners. There were numerous questions answered regarding plans for property, including future development, road replacement and other questions. The Mayor indicated that there were no plans to upgrade the road, upgrade the bridge, or provide further access to other property owners for development purposes. The Mayor also indicated that the property annexed would currently remain zoned as it is now.

Motion by Leia Ryan, seconded by John Adams, to approve the liquor license renewals for Dar's Pub and The Corner Bar. Motion passed unanimously.


Attorney Dick Gorman reviewed the domestic chicken ordinance, and provided copies to all interested people. The ordinance was laid on the table pending a full council review.


**MINUTES OF THE CITY OF GOODHUE
